Procedure for Application of AAOS A2O CAC

Introduction

 Once a dog has gained sufficient CAC Awards in accordance with Dogs Australia Regulations Part 5 – Show, Section 9A.7 the registered owner/s of the dog may make application to the A2O Secretariat through their Member Body for the title of A2O Champion, A2O Grand Champion or A2O Supreme Champion.

Procedure

- 2. The procedure for making application for the abovementioned titles shall be as follows:
 - a. The owner/s are to complete the attached form provide the original pedigree and the copies of the CAC's being claimed to Dogs Victoria. Along with the prescribed fee as determined by Dogs Australia and the Member Body.
